Thanks to a grant from the Global Philanthropy Partnership and the Urban Sustainability Directors Network and in partnership with the Council for Responsible Sport, the City of Eugene (Oregon) has crafted a pioneering Responsible Event Framework to help event stakeholders understand, adopt and achieve triple bottom line objectives.

Providing real-world best-practices and up-to-date resources, the Framework lays out practical recommendations and concrete responsible event examples from cities, businesses and organizations involved with the project, representing events in Boulder (Colorado), Chicago, Eugene, Houston, Minneapolis, Phoenix, San Jose (California) and Washington, D.C.

Taken together, the resources and recommendations included in the Responsible Event Framework offer meaningful and achievable ways for event stakeholders to align their values externally with other stakeholders and to link larger policy or organizational goals internally with actual value-added practices. This establishes a collaborative, inclusive "event ecosystem" that brings stakeholders and organizers together to catalyze community growth, economic stability and environmental health.
